Annual Vacation Request Form English Language Institute Students

If you have been enrolled for at least 4 consecutive ELI sessions, you may request an annual vacation if you intend to enroll in the next session. If approved for a vacation, you may take 1 session off and still maintain valid F-1 status. During your annual vacation, you may stay in the United States or travel outside of the US.

Annual Vacation Eligibility:

- » Must be enrolled for 4 consecutive ELI sessions
- » Must intend to enroll in the next session immediately after your annual vacation
- » Must be in valid F-1 status
- » Cannot take annual vacation after level 8. (An exception may be possible for students continuing to Level 9. Please speak with an immigration advisor. No annual vacation will be approved between Levels 9 & 10.)
- » Students in the ELI Undergraduate Track or Global Achievement Academy II or III programs are not eligible for **Annual Vacation**
